

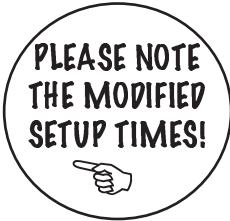


# Sacramento Swap Meet Vendor Application

### Vendor Setup Times:

- EARLY SETUP FOR RESERVED/ASSIGNED SPACES IN LOT 26 ONLY - Friday, October 11, 2019, 5:00 pm through 9:00 pm. Lot 26 Vendors may camp overnight in their vendor space(s). No entry to the grounds after 9:00 pm (this includes re-entry for vendors already setup). Vendor gates will re-open at 5:00 am on Saturday, October 12.
- Saturday, October 12, 2019, 5:00 am through 7:00 am. NO entry for vendor setup after 7:00 am. Vehicle traffic is NOT allowed in swap meet area after 7:00 am. SATURDAY SET UP IS FOR ALL PARTICIPANTS (Reserved/Assigned, Unassigned, Car Corral, and Show-N-Shine)

### Vendor and Show-N-Shine Teardown Times:

- Saturday, October 12, 2019, at 1:00 pm. Vendors may begin to breakdown and leave at 1:00 pm on Saturday. No breakdown can begin before 1:00 pm. No vehicle movement within the swap meet area will be allowed between 7:00 am through 1:00 pm.

### Swap Meet Public/Buyer Gate Time and Show-N-Shine Show Time::

- The Swap Meet will be open to public buyers beginning at 7:00 am (or there-about) on Saturday, October 12, 2019.

### Vehicle Movement During Public Swap Meet Times:

- NO vehicle movement will be allowed within the swap meet area and Show-N-Shine area between 7:00 am through 1:00 pm on Saturday, October 12.
- NO breakdown or leaving until after 1:00 pm on Saturday, October 12.

### Vendor Spaces:

- One (1) assigned vendor space is approximately 20' wide by 20' deep. One (1) unassigned vendor and Car Corral space is approximately 10' wide by 18' deep. One (1) commercial space is approximately 30' wide by 15' deep. One (1) unassigned non-automotive/antique space is approximately 10' wide by 15' deep.
- Vehicles may park within your rented vendor space.
- Vehicle traffic in and out of vendor spaces and swap meet area is **NOT** allowed from 7:00 am through 1:00 pm on Saturday, October 12, 2019.
- If you do not want to park in your vendor space, parking space is available in the designated Vendor Parking Lot and may be purchased for an additional fee. Any vehicle that is parked in an unauthorized area is subject to tow. Cal Expo also has an RV Park available with full hookups – contact Cal Expo at 916-263-3187 for rental info.

### Swap Meet Items for Sale:

- Swap meet items for sale should be AUTO RELATED or genuine 40's, 50's, 60's, 70's NOSTALGIA ITEMS.

### Space Clean Up:

- Vendors are required to clean up their rented space at the conclusion of the event. Cal Expo is kind enough to allow us to hold the Swap Meet on their grounds, but we must leave the grounds clean. Failure to clean your vendor space may result in denial of future participation in the Swap Meet.

### Electricity:

- Electricity is not available on the swap meet grounds.

### Generators / Loud Speakers / Loud Engines:

- Loud generators/speakers/music/engines/ etc. and generator exhaust fumes must NOT offend your neighbors. Please, be considerate and make sure that you comply. If you have problems contact swap meet personnel in the orange vests.

### Insurance:

- Swap meet vendors must maintain liability insurance in accordance to the requirements of the State of California (land owner and site lessor).

### Seller Permits:

- Swap meet vendors are responsible to be in compliance with all applicable resale and other license requirements.
- If you do not have a seller's permit and are not an exempt or an occasional seller, you MAY NOT sell at the swap meet.
- A temporary seller's permit can be obtained at any local Board of Equalization office, at no cost to you. The business address on your temporary permit should be the address of the temporary selling location. The mailing address is your permanent place of business or residence.
- Occasional sellers are persons who will not be making a series of sales sufficient in number, scope and character to constitute an activity requiring the holding of a seller's permit. Occasional sellers typically include persons who have cleared out their garage of their own used items, and sell only those items.
- Vendor shall hold Swap Meet Operator harmless for any regulatory breach.

### Tents / Easy-Ups:

- All tents and easy-up type structures must be certified fire safe and must have attached decal showing such. All non-fire safe tents are subject to removal.

## SWAP MEET SPACES

**\$50 & \$35**

Outside open spaces. For private individuals selling used parts & cars. Includes 2 admission passes per vendor (NOT PER SPACE). Additional admission passes may be purchased below for \$10 or at the Swap Meet Office for \$12 each. You are permitted to camp in your space on Friday night October 11th. NO ALCOHOL PERMITTED. AUTOMOTIVE ITEMS ONLY. NO YARD SALE ITEMS.

- Reserved / Assigned Spaces. Approximately 20' wide by 20' deep. Located in Lot 26. \$50 each.
- Reserved / Assigned - End of Aisle Spaces. \$60 each **if available**.
- Unassigned Spaces. Approximately 10' wide by 18' deep. Located in Lot A. \$35 each.

For those with multiple Reserved/Assigned spaces - Would you like your spaces:  Side-by-side or  Back-to-back

**Note: 2 passes per Vendor - not per space**

NO SELLING OF PARTS or easy-up tents allowed in the Car Corral area. No tow vehicles allowed to be parked in Car Corral area. Tow vehicles must be removed and parked in Vendor Parking. \$35 each.
